# **ZOOM** Board of Directors' Meeting on February 11, 2023

February 11, 2023, Meeting was called to order by President Minh Buhi at 5:10pm with 9 members in attendance. The minutes from the 12/18/2022 zoom meeting were read.

Ken Barbi spoke about our websites and gave a brief rundown of the issues with the current hosting service (iPage.com). Their service interruption is currently being investigated by the Federal Trade Commission and the FBI Cyber Crimes Division. He has transferred the hosting of our two websites (and Dixie's web site) to another company (InMotionHosting.com) so that MAAVS shares the cost for hosting websites with Dixie through the service he uses. MAAVS can now be found under <a href="www.mAAVS.org">www.midatlanticafricanvioletsociety.org</a>

Linda Stinette provided a report of \$7,908.71 as the account balance as of January 24, 2023, our deposit for the hotel has already been paid for November 2023 and all the expenses paid out for the 2022 convention have cleared out account.

Sandy Pines reported that the 2023 contract with the hotel has been signed and she has a contract for 2024 (securing dates of October 30 through November 3, 2024). For the 2024 show they offered a room rate lock in at \$122. Only a \$3.00 increase over the 2023 rate, all other prices would be the same. At this time the board has decided to hold off on signing the contract for 2024 as there are some concerns about having the funds to have a show in 2024.

It was brought up that Sandy will not be holding the position of Convention Chair for the 2024 year and that we would need someone to volunteer and begin working on plans for the location if we want to have a show in 2024.

#### Old Business:

Advertisement postcards will be printed to advertise the show and sent out to vendors to send out with orders and be sent out to shows to hand out at their local shows.

INSV test kits, it was confirmed that we have met and exceeded the number of tests needed to get the discount rate, Minh is going to reach back out to the company and see what the discount rate will be with the number of tests he is going to order. Minh will be sending out an email to the affiliate club

members that placed their order with the final price per kit as well as an estimated ship date, right now he is anticipating that to be early March.

The Facebook pole showed that the 2023 show theme will be Violets in the Animal Kingdom, Sue H. made a motion to follow through with the online vote and Ken B. seconded it and was agreed by all. Linda K. will work with Sue H. to update the show schedule and submit it for approval.

#### **New Business:**

Minh reviewed the balance sheet from the 2023 show and pointed out that the show costs MAAVS a total of \$ 3,441 and that if we did not increase prices to raise \$ 5,441 we would not be able to afford to hold a show in 2024.

A motion was made by Jackie L. that the price increases below would go into place immediately, the motion was seconded by Linda K. and all attended agreed.

Membership dues \$25.

Joint Membership dues \$30.

Commercial Membership dues \$30.

Affiliate Membership dues \$30.

Convention registration fee would be \$55 - early bird rate, \$65 after a date that will be determined soon.

It was also agreed that MAAVS will no longer pay any percentage of the meals for the members at convention, we estimate that this will save us approximately \$600 to \$700.

Linda K. will print the posters at no cost for the hotel to be displayed to bring attention to the show, this should save us about \$150 to \$200.

Sue H. brought up a concern about the commercial vendors not charging sales tax and this is going to be investigated moving forward.

Other ways to raise funds were discussed, Linda K. mentioned a raffle, Jackie L. mentioned a sort of make-n-take project event for anyone that signs up and pays a small fee, this would be opened to the public and advertised with a sign up required prior to the show. Ken B. mentioned sending a letter to life-

members asking for donations, Minh will draft and email a personal letter to the life-members.

There will be another board meeting held on April 15<sup>th</sup> at 5pm via zoom, a link will be sent out much closer to the date.

# **ZOOM** Board of Directors' Meeting on December 18, 2022

Zoom Meeting called to order at 2:12 by President Minh Bui with 11 members attended.

Treasurer report given by Linda Stinnette the balance as of November 21, 2022, bank statement is \$9,361.08 – all hotel expenses from the show have been paid

#### **New Business:**

It was agreed upon that Minh will revise the artwork on the postcard for advertising the show. Postcards will be printed and sent out to different affiliate clubs to pass out at their shows as well as sent to vendors to send out with their orders. A motion by Linda Stinnette was made to approve this and seconded by Rodney Barnett. In 2022 a total of 750 postcards were ordered.

2023 Convention will be held in Baltimore MD, Jackie Leitzel made a motion to lock in the hotel for the 2023 convention at the same hotel and was seconded by Linda Stinnette – all approved.

The hotel wanted \$130/night Sandy was able to negotiate it down to \$119/night. A total of 77% of the rooms have to be booked, we don't anticipate that being an issue as we hit our target in 2022.

Vendor/Ways and Means table rentals will be going up to \$30 per table verse 2022 rates at \$15 per table.

In 2022 we were not charged for linen rentals we will be charged in 2023 and the rental fee will be \$25.65 per table increasing the cost for 2023 by \$1,256.85

The hotel has guaranteed us a minimum of 3 handicap rooms, they wanted to charge us for electricity into the sales room for the vendors, Sandy was able to negotiate that out.

Vendors were happy with the sales in 2022, and Sandy will check with the hotel to see if they will give us any kind of discount if we book 2024 with them as well.

It was discussed that we would offset some of the added costs by raising the Registration Fee to \$45 and that there will be a \$5 charge to enter the show for non-registered attendees. A sign-up sheet will be set up for MAAVS members to take turns setting at the entrance welcoming guests and collecting the entry fee.

2023 show dates will be November 2nd through 4th and a judging school will be offered and held on November 1<sup>st</sup>.

Sandy Pine agreed to maintain her position as show chair for the 2023 show, but this will be her last year in doing so.

Linda Kilby and Minh Bui will be co-chairs again for the 2023 show. Rodney Barnett will hold the position of Judges Chair again in 2023.

Joyce Stork will be joining us to handle the judging school.

Jackie Leitzel will download the show software to serve as a backup if needed.

A change to the convention guide will be made to state that a digital copy of the show/yearbook will be emailed out to members that do not attend show instead of a hard copy being mailed out to cut down on costs, unless they are a member that has requested the memo be sent out via mail.

Linda Stinnette discussed the 501 c and what that qualifies us for, Sue Ramser recommended Linda reach out to Terri Post with AVSA and give an update when one is available.

Minh talked about INSV and the test kits, an email will be sent out the first week of January by Jackie Leitzel to all affiliate clubs with the information about the test kits and see how many members would be interested in them. It was also brought to our attention that Marie Glass (Black Oak Violets) has detected that she has INSV and discarded a lot of her inventory.

At 3:53 pm Minh closed the meeting.

# General Membership Meeting on November 12, 2022



Sue Hoffmann, current president, opened the meeting at 3:00pm.

Linda Stinnette gave the proposed budget for the next year. Sharon Long read the zoom meeting minutes from 2021 for Barbara Greenawalt. There were no corrections. Rich Follett made a motion to approve with Linda Abplanalp second the motion. The membership unanimously approved the minutes.

Rich Follett volunteered to fill the open position of parliamentarian. Sue Hoffmann accepted his offer.

Linda Kilby gave this report on the MAAVS show: 29 members exhibited, 203 horticultural exhibits, 35 design exhibits, 162 blue ribbons in horticulture, 41 red ribbons in horticulture, 17 blue ribbons in design, 13 red ribbons in design, 3 white ribbons in design, and 2 exhibits were not judged. Minh said there are a lot of awards to be given out tonight at the dinner meeting.

Jackie Leitzel gave this membership report: 6 new members, 9 affiliate memberships, 8 commercials memberships, 83 current members from last year which is an increase of 5, and there are 34 memberships set to expire in December 2022.

La Donna Hopson gave a good report on the Ways and Means which gave the club \$605.00 from the sale, and someone had given the \$5 as a donation to MAAVS.

Sandy Pine gave a brief report on the ongoing negotiations with this hotel for next year. She said several things have gone up, but she was still working with the hotel on the pricing.

Sue Hoffmann announced the slate of officers for the next 2 years: President: Minh Bui, Vice-President: Rodney Barnett, Secretary: Jackie Leitzel, and Treasurer: Linda Stinnette. She asked for any other nominations, but there were none. Bill Schmidt made a motion to accept the slate of officers, and Kitty Hedgepeth seconded the motion. The general membership voted unanimously for the slate with no one against.

Minh Bui and Linda Kilby both wanted to be show co-chairmen next year in 2023.

### **New Business:**

The question was raised about having a photo exhibit in the next show. It was said AVSA does not have a scale of points to judge photo exhibits, and since we are an AVSA show we can't have it judged, but we could have it as an exhibition. The show committee will decide on it.

Rodney Barnett said he thinks we need to pick two hotels, one in north and one in south, that work for us and alternate between the two. It would make it easier for the convention chair who has to look for a hotel. We also need to be aware of the dates for other violet show to not have conflicting dates for shows. The advertisement for the show needs to have increased local advertisement to bring in more traffic for the vendors and show. He pointed out that our dues have not increased since the beginning and all other costs have increased for MAAVS so we need to consider a increase in dues. These are things that the new board will consider.

# Impatiens Necrotic Spot Virus (INSV) by Ken Barbi

Several members have reported receiving African violets from commercial sources that are infected with the Impatiens Necrotic Spot Virus (INSV) in the Fall of 2022 in the Mid-Atlantic states and Florida.

This virus has been diagnosed in African violets and other gesneriads, and has no cure. It is transmitted by notorious THRIPS. It has wiped out entire greenhouse stocks of several commercial growers, and destroyed members' collections. entire other symptoms mimic common problems we have faced over the years such as mites, poor culture, water spots, leaf mottling, etc.

The problem is something we all need to know about, particularly how to combat the virus. The only positive way to determine if your suspect plants have INSV is to perform a test. Test kits are available from a number of sources. Once you determine a *single plant* in your collection has the virus, you can be sure all your plants are at

risk if you have thrips which carry the virus. **Destruction of infected plants** is the only cure, and control of thrips is the key to prevention. Some members are destroying their entire collection.

So now you say, I have tried everything to kill those little bugs. Science has come to the rescue in the form of an insecticide called Avid. There are other products as the chart below from AVSA shows. I thought it important enough to bring it to your attention. If you want more detail, there is a fine collection of research from the University of Massachusetts. Texas A&M. and Colorado State Cooperative Extension On-Line. Search the internet for "Impatiens Necrotic Spot
