- Unlike the multiple sections we have in a normal show, we have limited the sections to:

\* Collections of 3 plants - AVSA, MAAVS or Russian

- \* Standards All Green and Variegated varieties
- \* Semiminiature All Green and Variegated varieties
- \* Miniature All Green and Variegated varieties
- \* Species
- \* Trailers All sizes and variegations
- \* All Other Gesnariads
- Each member may have **as many entries** as they wish.
- Decide which plants you would have taken to our show.

- Take a picture as you would want the plant to be seen with the plant placed on a dark background if possible.

# Proposed MAAVS Bylaws and Standing Rules Changes

Because of events beyond MAAVS' control - - the COVID Pandemic, the Executive Committee (President, Vice-President, Secretary, and Treasurer) have decided *not to have our by-annual election of officers*, but rather to defer the election until November 2022. The proposed candidates have all agreed to wait until then to stand for office. To implement this decision, our Bylaws and Standing Rules must be amended during our upcoming 7:00 pm November 13<sup>th</sup> ZOOM Annual Membership Meeting as follows:

Change Bylaws Article VII NOMINATIONS AND ELECTIONS SECTION 4. ELECTIONS to read (additions are shown in red):

Elections shall be held at the annual meeting. Voting shall be by ballot except where there is only one name in nomination, in which case it may be dispensed with in favor of a viva voice vote. In the event of a declared Medical Pandemic, such as COVID-19, the Executive Committee will decide whether or not to postpone the election to another year when it is safe to meet in person face-to-face as a group.
